## BOARD OF DIRECTORS

Bylaws Article V, Sec.1-2: Number. The board shall have a minimum of five (5) and a maximum of twenty-five (25) members. Manner of Selection: Officers and directors shall be elected at the annual meeting. The board may appoint additional directors, over and above the directors elected at the annual meeting, as they deem necessary to carry out the work of the League. The elected officers and directors shall constitute at least sixty (60) percent of the board, and the total shall not exceed 25. Term of Office: The term of office of the elected and appointed board members shall be two years. Terms of the elected directors shall be staggered so that approximately half are elected in even-numbered years and the balance, in odd-numbered years.
